#### What is the purpose of this update?

# What are the risks of investing?




## **Example of how this applies to an investor**

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund charges were deducted of \$1,057 (that's 10.57% of her initial \$10,000). This gives Jane a total return after tax of \$1,057 for the year.
