What is the purpose of this update?

This document tells you how the Forsyth Barr Listed Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Forsyth Barr Listed Property Fund invests in selected listed property vehicles. We aim for positive long-term returns. These kinds of investments will typically have moderate to high levels of movement up and down in value.

What are the risks of investing?

Risk indicator for Forsyth Barr Listed Property Fund:

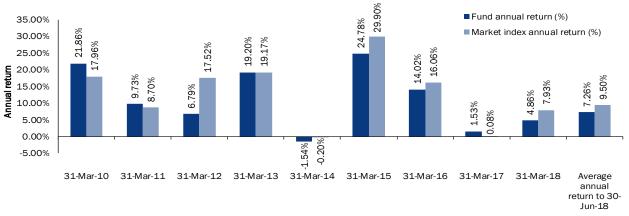

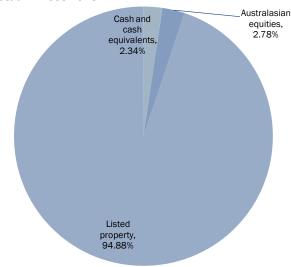
Example of how this applies to an investor

Jane had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted but before tax of \$1,006 (that is 10.06% of her initial \$10,000). This gives Jane a total return after tax of \$958 for the year.
