

Navigator makes it easy for you to make contributions or withdrawals at any time. You will have continuous visibility of your portfolio through Forsyth Barr's website and apps.


Reviews and Reporting

Your Adviser will deliver you an annual review detailing your portfolio's performance and reviewing your investment objectives and financial circumstances. You will also receive regular reporting including quarterly portfolio reports and year-end tax reports.

Defining your objectives

Our investment process helps formulate your strategy and define your objectives.

The investment process

We'll start by sitting down with you to learn about your investment objectives and to introduce you to our service. Investment objectives include your desired investment outcomes, priorities and preferences, and the level of investment risk you are comfortable with.

1. Developing your plan

You can also meet at any time with your Investment Adviser to discuss your Navigator portfolio or revisit your plan and objectives.

2. Implementing an agreed strategy

We will help you agree an investment strategy.

3. Reporting progress against objectives

We will send you quarterly and end-of-year reports.

4. Reviewing portfolio outcomes

Administration and safe custody

Navigator portfolio holdings are held in Forsyth Barr's separate custodial service on your behalf.

This allows Forsyth Barr to manage your investments for you, and to provide comprehensive reporting to you. The custodial service for your portfolio is provided by Forsyth Barr Custodians Limited.

What is a Custodian?

The purpose of a Custodian is to hold your investments on your behalf and to enable their administration. The Custodian (or a sub-custodian appointed by the Custodian) is the legal owner of the investments, but you continue to be the beneficial owner at all times.

What protections are in place?

The Custodian is a separate legal entity from Forsyth Barr Investment Management Limited and Forsyth Barr Limited, its board has a majority of independent Directors, and its only activity is to hold investments on behalf of clients. We maintain a comprehensive control environment for our custodial services, which are subject to annual assurance reviews by a qualified auditor. You may request a copy of the most recent assurance report from your Investment Adviser.

Portfolio holdings are held securely on your behalf in Forsyth Barr's separate custodial service.
