Forsyth Barr KiwiSaver Scheme Personal Choice - New Zealand Equities Fund



What is the purpose of this statement?

This statement provides key information about the Forsyth Barr KiwiSaver Scheme Personal Choice - New Zealand Equities Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The fund aims to maximise the capital returns available from investing in New Zealand equities. This fund is a high conviction, "benchmark unaware" fund.

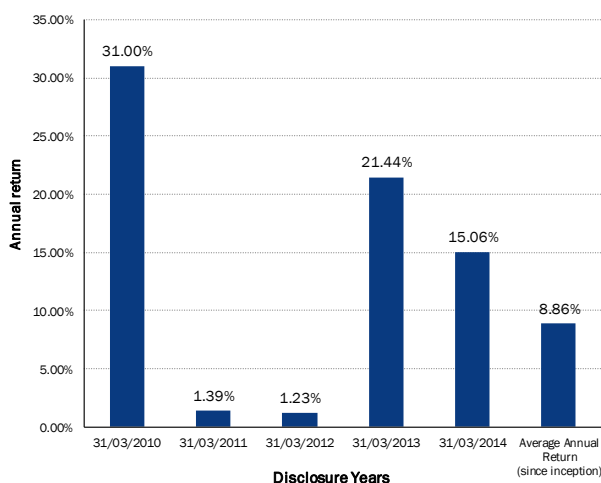

Members were also charged membership fees of \$36 over the year.

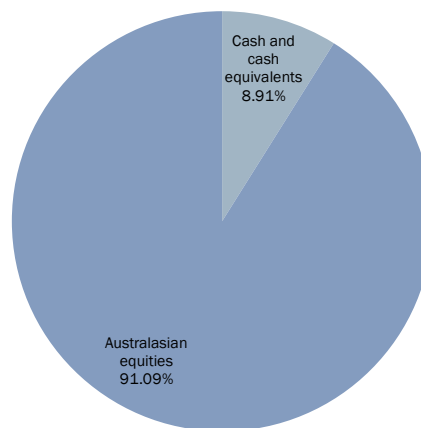

Example of how this applies to a member

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$1,506 (that's 15.06% of her initial \$10,000). Jane also paid \$36 in membership fees. This gives Jane a total return of \$1,470 for the year.
