What is the purpose of this statement?

This statement provides key information about the Forsyth Barr KiwiSaver Scheme Personal Choice – New Zealand Equities Sector. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The general objective of the fund is to achieve positive long-term returns by investing in selected New Zealand equities, subject to the higher risks associated with investments in equity markets. The fund is actively managed.

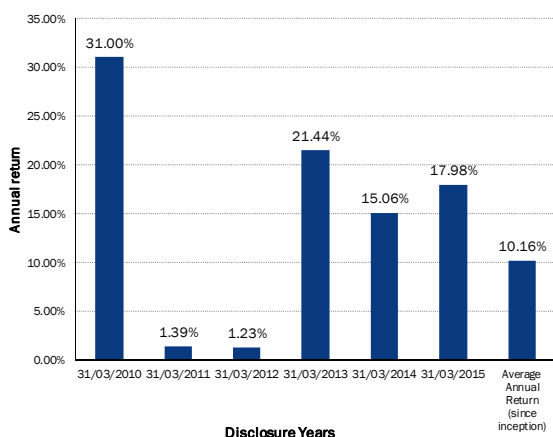

How has the fund performed in the past?²

Members were also charged membership fees⁴ of \$36 over the year.

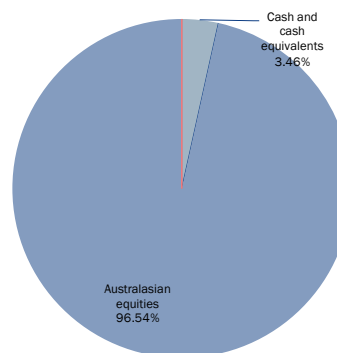

Example of how this applies to a member

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$1,798 (that's 17.98% of her initial \$10,000). Jane also paid \$36 in membership fees. This gives Jane a total return of \$1,762 for the year.

Notes

- Returns in this statement are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax rate may be lower.
- For the purpose of return calculations, the closing unit prices as at 28 February 2014 and 31 March 2014 for the Fund were recalculated to incorporate daily performance fee accruals excluded from the published unit prices.
- Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance).
- Membership fees are the fixed dollar charge for membership in the KiwiSaver Scheme.
- Kevin Stirrat, Craig Alexander, Malcolm Davie and Rob Mercer are employees of Forsyth Barr Limited (and not the manager). The manager has delegated part of the day to day management of the scheme to Forsyth Barr Limited.
- Forsyth Barr Investment Management Limited (previously known as Forsyth Barr KiwiSaver Limited) is the manager of the Scheme and amalgamated with Forsyth Barr Funds Management Limited (the manager of the Forsyth Barr Investment Funds, into which the Scheme invests) with effect from 27 February 2015.

Revised Disclosure Statement

This disclosure statement has been revised to amend two references to Forsyth Barr KiwiSaver Limited in the Manager's certificate. Forsyth Barr KiwiSaver Limited amalgamated with Forsyth Barr Funds Management Limited (the manager of the Forsyth Barr Investment Funds, into which the Scheme invests) on 27 February 2015 to become Forsyth Barr Investment Management Limited. As a result, the references should have been to Forsyth Barr Investment Management Limited.
