What is the purpose of this statement?

This statement provides key information about the Forsyth Barr KiwiSaver Scheme Growth Portfolio. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The Growth portfolio option provides investors with the choice of predefined investment sector exposures across cash, fixed interest, domestic and global equities.

The selected exposure and ranges are consistent with a growth investment approach which involves a higher level of investment risk and commensurate higher investment returns over the medium to long-term.



How has the fund performed in the past?

## What fees were members charged?

The returns above are after deductions for fund fees<sup>2</sup>.

Members were also charged membership fees<sup>5</sup> of \$30 over the year to 31/03/13.

## Example of how this applies to a member

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$1,022 (that's 10.22% of her initial \$10,000). Jane also paid \$30 in membership fees. This gives Jane a total return of \$992 for the year.

## Notes

- <sup>1</sup> Returns in this statement are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax rate may be lower.
- <sup>2</sup> Fund fees are fees charged as a percentage of a member's interest in the fund (i.e. as a percentage of their KiwiSaver account balance).
- <sup>3</sup> A change in the fee structure from 1 April 2013 resulted in an increase in the management fee to 1.0% and scheme expenses to 0.2% (these are included in "other fees and costs"). However, total fund fees reduced due to full rebating of the underlying fund management fee (also shown as part of "other fees and costs"). The calculation and sample provided here assumes 100% has been invested in this fund.
- <sup>4</sup> Fees arising from investments in funds managed by managers other than associated entities of Forsyth Barr KiwiSaver Limited are not readily available given that publicly available unit prices are already net of fees. These fees have therefore been estimated by applying the fee percentage charged by the third-party manager at each month-end against the fund's exposure to the relevant fund.
- <sup>5</sup> Membership fees are the fixed dollar charges for membership in the KiwiSaver scheme. From 1 April 2013, individual membership fees increased from \$30 to \$36 per year.
- <sup>6</sup> Kevin Stirrat and Craig Alexander are employees of Forsyth Barr Limited (and not the manager). The manager has delegated part of the day to day management of the scheme to Forsyth Barr Limited.

## Revised Disclosure Statement

This revised quarterly disclosure statement has been amended to provide clarity at note 3 in relation to the increase in management fee and scheme expenses. In addition, the manager's certificate has been updated to clarify the manager and scheme name.

Since inception average annual return displayed in the "How has the fund performed in the past?" bar graph has been updated to reflect the return from 26 June 2008. Previously, the since inception average annual return only reflected the return from 30 June 2008.

Subsequent to the revisions stated above, this disclosure statement has been further revised to restore the "Top 10 holdings" to actual holdings as at 30 September 2013.
