What is the purpose of this statement?

This statement provides key information about the Forsyth Barr KiwiSaver Scheme Personal Choice - Premium Yield Fund. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

Description of the fund

The general objective of the fund is to achieve positive long-term returns by investing in selected international and domestic debt and other securities, subject to the risks of investing in securities of that kind. The fund is actively managed.



How has the fund performed in the past?

Members were also charged membership fees³ of \$36 over the year to 31/03/14.



Example of how this applies to a member

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$550 (that's 5.50% of her initial \$10,000). Jane also paid \$36 in membership fees. This gives Jane a total return of \$514 for the year.
