## Forsyth Barr KiwiSaver Scheme Personal Choice – Listed Property Sector



### What is the purpose of this statement?

This statement provides key information about the Forsyth Barr KiwiSaver Scheme Personal Choice – Listed Property Sector. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

### Description of the fund

The general objective of the fund is to achieve positive long-term returns by investing in selected New Zealand and Australian listed property vehicles, subject to the higher risks associated with investments in listed property investments. The fund is actively managed.

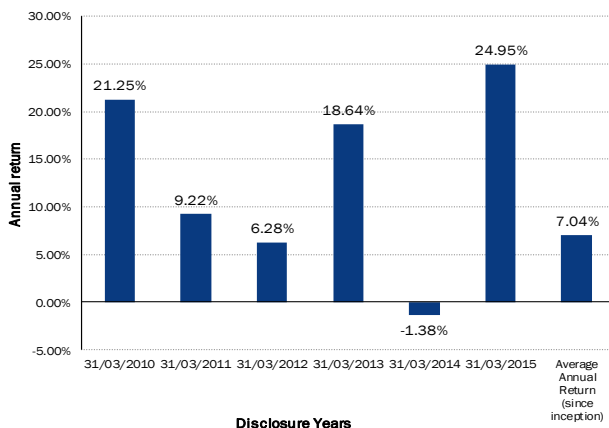

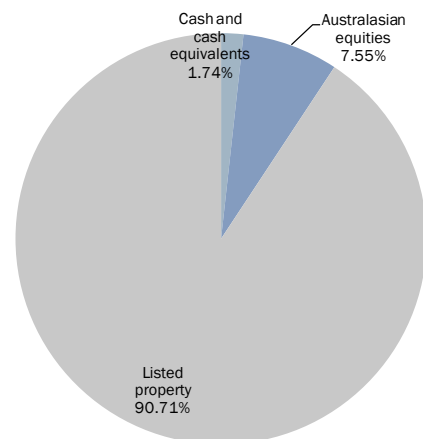
### Example of how this applies to a member

Jane had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jane received a return after fund fees and tax were deducted of \$1,280 (that's 12.80% of her initial \$10,000). Jane also paid \$36 in membership fees. This gives Jane a total return of \$1,244 for the year.
