## Forsyth Barr Commentary

MFT scores highest in its social sustainability due to its strong supply chain management, involvement in the community and stakeholder centric business model. As a global logistics player, MFT recognises the impact its business has on climate change and greenhouse gas emissions. While the Company scores poorly on emission intensity (such is the nature of its business), MFT has emission reduction targets and solid risk management in place to offset this. Furthermore, as a result of its largest emission sources coming from key operating activities/costs, MFT already measures these activities intently. MFT's E and G scores are solid with the key risks including the long tenures of its Board and auditors and the lack of a tax governing framework.
