Forsyth Barr Commentary

SKC remains in the Fast Follower category this year. SKC experienced a challenging year with the anti-money laundering investigations in South Australia continuing, and the proposal to suspend its gaming licence in NZ highlighting the company's failure to meet its duty of care to problem gamblers. Its acknowledgement of these historical failings of governance and management reduced its 'G' score materially. The existence of these issues will act as a significant headwind to SKC improving its score in coming periods. Excluding these issues (though we appreciate that is hard to do at the moment), SKC's C&ESG scorecard is solid with its 'C' & 'S' scores above both the sector and NZ averages.
